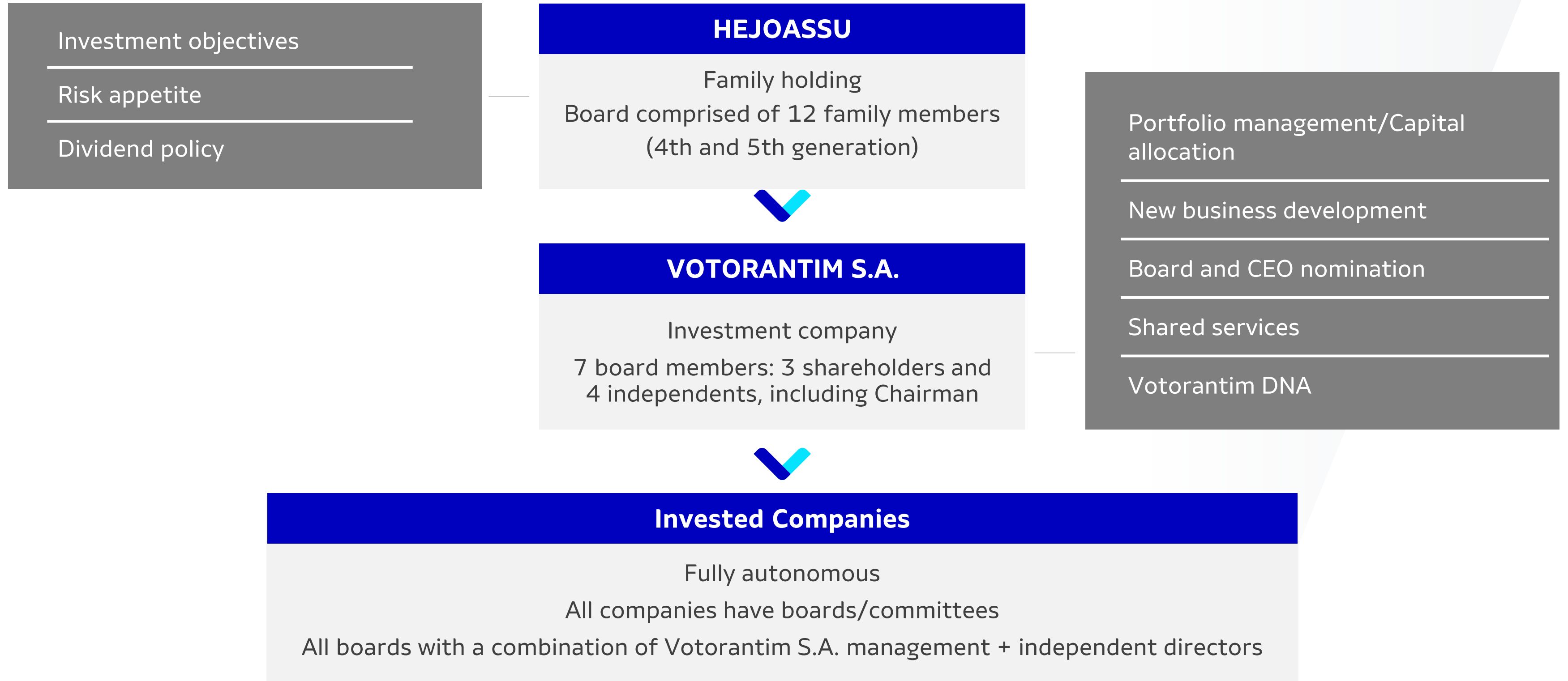

ESG - Corporate Governance framework



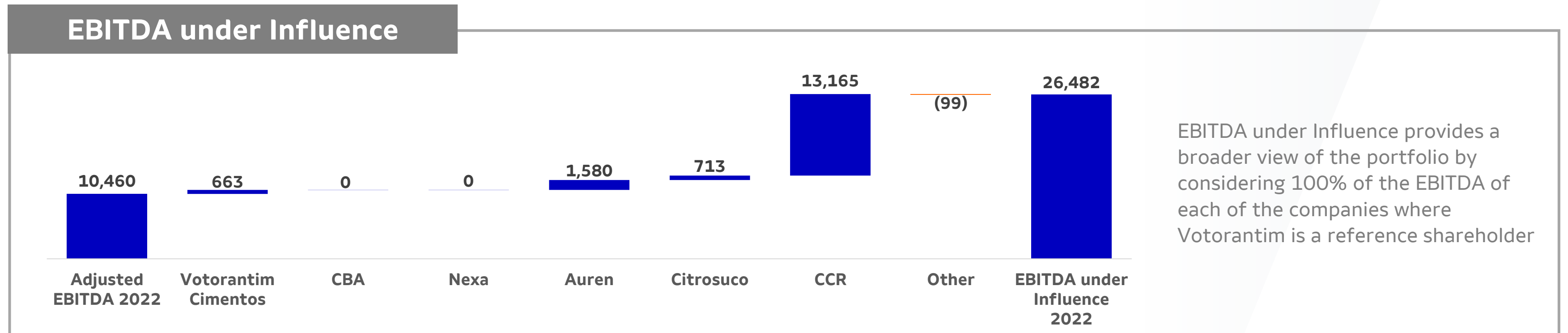
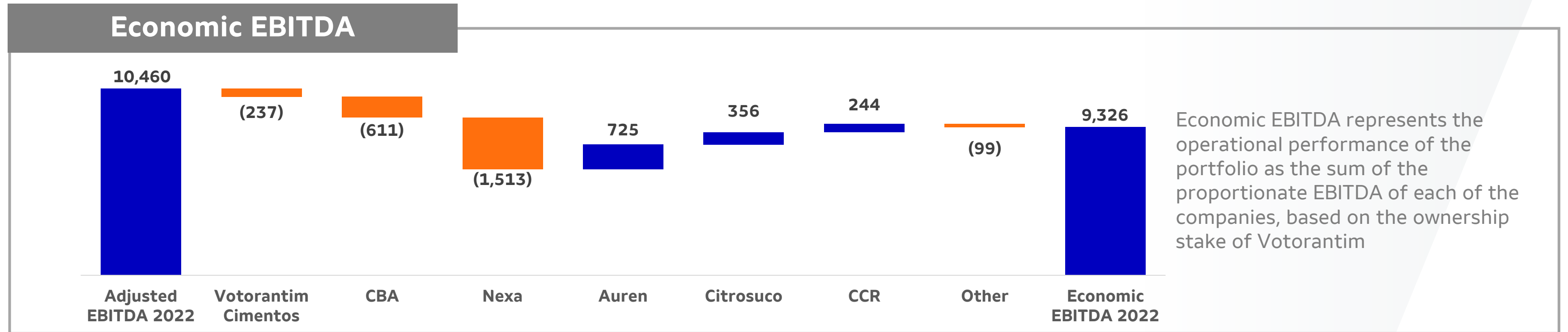
2022 Consolidated Results

R\$ billion



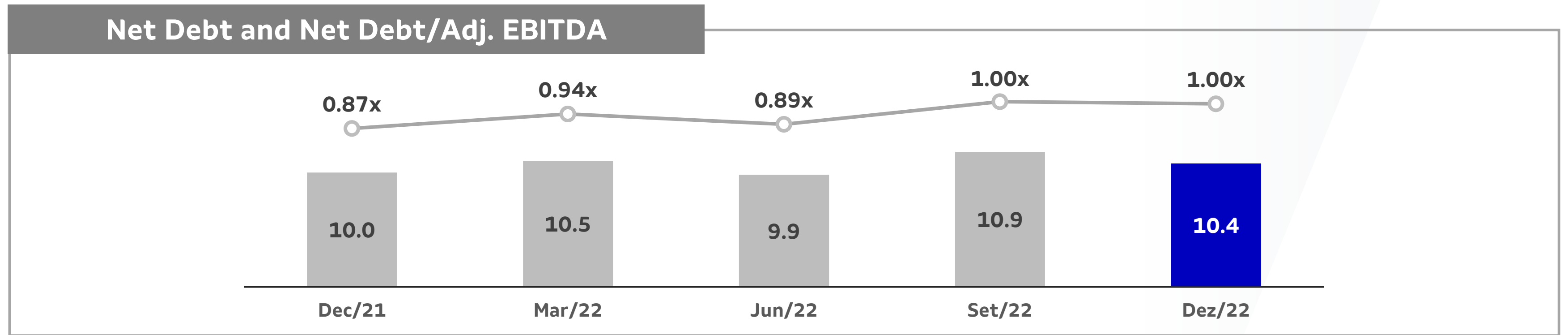
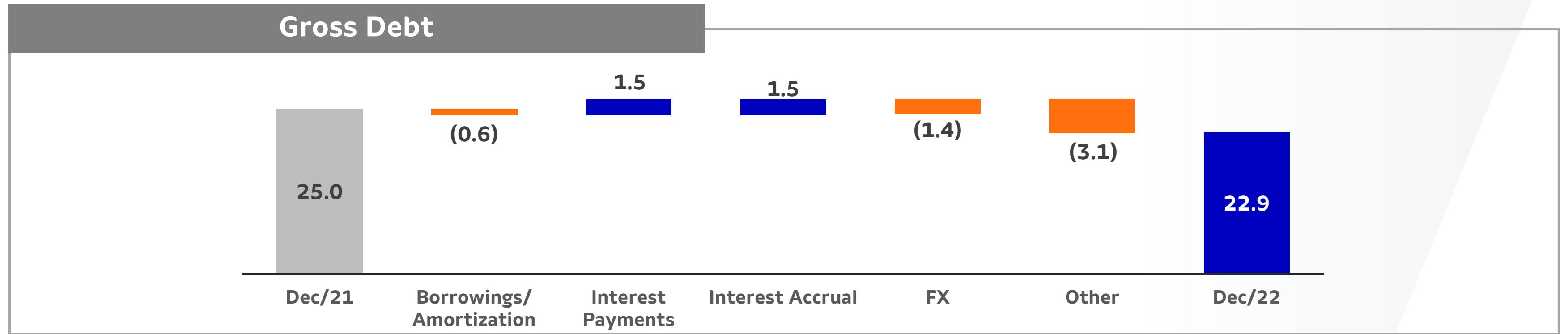
2022 Economic EBITDA and EBITDA under Influence

R\$ million





2022 Indebtedness & Liquidity
